# Your New Electricity Prices Starting January 1, 2019 - Residential & Small Business Customers

A number of rate changes took effect January 1, 2019, for residential and small business customers. The following outlines the changes according to how these charges appear on your bill.

### **Your Electricity Charges**

In July 2018, the Ontario Energy Board announced new Time-of-Use pricing under the Ontario Fair Hydro Plan. These rates continue until April 30, 2019 as follows:

Time-of-Use Pricing –Winter/Spring (November 1, 2018 to April 30, 2019)					
Winter Off-Peak	Weekdays 7:00 p.m. to 7:00 a.m.; Weekends & Holidays	6.5 cents per kWh			
Winter Mid-Peak	Weekdays 11:00 a.m. to 5:00 p.m.	9.4 cents per kWh			
Winter On-Peak	Weekdays 7:00 a.m. to 11:00 a.m. and 5:00 p.m.to 7:00 p.m.	13.2 cents per kWh			

If you purchase electricity from a retailer, your electricity price is charged according to your contract. There is also an additional line item called Global Adjustment on your bill, which is priced at the monthly IESO posted Class B Global Adjustment rate (<a href="www.ieso.ca">www.ieso.ca</a>) plus a Rate Rider for Disposition of Global Adjustment Sub-Account (2019) of 0.0013/kWh effective January 1, 2019. Through the Ontario Fair Hydro Plan, customers purchasing their electricity through a retailer also receive the Global Adjustment Modifier credit of (0.0344)/kWh, effective May 1, 2018 – April 30, 2019. #### **Delivery Charges**

The Ontario Energy Board has approved a rate increase for **Delivery Charges** effective January 1, 2019. These charges cover the cost of delivery through transmission and distribution lines. The estimated bill impact for a residential customer using 750 kWh per month is a decrease of (\$0.30) per month. There have been no changes to regulatory charges.

## 8% Rebate

Continuing from January 1, 2017, the Ontario government is providing residential customers, farms and small businesses with an 8% rebate on your electricity costs, which is equal to the provincial portion of HST.
