Festival Hydro is in the process of preparing our Billing System to enable us to invoice your water and sewage charges on behalf of the Town of St. Marys. Where possible we would like to add these charges to your existing electricity account.

To prepare for this transition many pieces of information are being reviewed. During our first review of your St. Marys' water account details we have not been able to find an exact match to an existing electricity account.

If you have an existing hydro account at the location in question, to which you would like to add the water and sewage billing please complete Form "A" (attached) and return it to our office. (fax: 519 271 7204, email customerservice@festivalhydro.com). Completed forms may also be dropped off to the Municipal Operations Centre, 408 James Street South, between the hours of 8:30 and 4:30, Monday to Friday.

If we do not receive a completed Form A from you by June 30th, 2016, we will create a new water and sewage account in your name. If you are interested in starting pre-authorized payments, please go to the forms section on our website <a href="https://www.festivalhydro.com">www.festivalhydro.com</a>, complete the form and return it to our office.

Currently your billing from the Town of St. Marys is on a bi-monthly basis. When the merge is complete your water meter will be read monthly at the same time as your electric meter and billed on a monthly basis. St. Marys bi-monthly rates have been converted to monthly rates. Payment will be remitted to Festival Hydro who in turn will send payment to the Town of St. Marys. We anticipate the transition to be complete by October 2016.
